HAVE COMMITTED

1) Violations of section 45E (re Medical Treatment) of the Public Health Act (Control of Disease) 1984 which (1) forbids regulations requiring a person to undergo medical treatment - which (2) includes vaccination (/injections) and other physical treatment.

Their action is a violation of the Nuremberg code against coerced Medical treatment, the core principles of which are included in the 1984 Public Health Act.

2) Conspiracy to Attempt Murder / manslaughter

BY THEIR DECISION (announced 13 Sept eg on Sky News where Chris Whitty is quoted) to implement medical injection of children aged 12-15 despite the rejection on 3 Sept of such a course of (universal) action by the JCVI (Joint Committee on Vaccination and Immunisation) – Ref

The implementation of this (experimental) injection program involves reported coercion/forcing in the form of “direction to a mass vaccination centre” if the child refuses the jab in school. It appears also the govt intends to bypass parental refusal by putting children through the Gillick Test of competence whereby they can “decide” for themselves (see <https://amp.theguardian.com/world/2021/sep/14/letter-sets-out-nhs-advice-covid-jab-consent-to-schools-in-england> . Dr Vernon Coleman reports on extensive coercion via extra financial incentives to doctors for jabbing children (see below link); apart from heavy media propaganda coercion.

IRRESPECTIVE of the issue of COERCION under the 1984 PHA the ”Covid” jabs themselves have resulted in (and would continue to result in) illness and deaths of many recipients (which would include 12-15 year olds) who would otherwise not get ill or die.

The decision by Whitty, Vallance and Johnson to implement the jabbing programme therefore is CONSPIRACY TO ATTEMPT MURDER / MANSLAUGHTER.

Around 28 June it was announced there have been over 1600 deaths in the UK and over 1 million adverse reactions to “Covid” jabs. These were underestimates and new figures say 30,000 deaths to end June according to “Yellow Card” reported data analysed from Official govt websites. It is further shown that the jab dramatically increases the risk of “Covid” type illness and infertility or death compared to the unjabbed. See:-
